



Latour capital exits Sogetrel

Paris, 29th January 2021

Following a transaction closed yesterday, Latour Capital has fully exited its investment in Sogetrel via a sale to its management team, supported by a consortium of funds led by Andera Partners.

Latour was invested in Sogetrel since Octobre 2018, through its second-generation vehicle. Sogetrel represents our second exit for Latour Capital II (after Syclef in 2020).

Created in 1985, Sogetrel is a major player in the integration of communication networks across its territories. It has established itself as a preferred partner of major public / private operators and local authorities, particularly in the deployment of very high-speed fiber networks.

Sogetrel is also a leading player in the electronic security market as well as the communicating solutions market (smart objects and smart cities). The company underwent significant growth both organic and inorganic under the leadership of its CEO Xavier Vignon.

Sogetrel's revenue increased from €250m in 2015 to more than €700m in 2020. The company employs around 4,500 employees, spread across 100+ agencies in France. The business is headquartered in Issy-les-Moulineaux (right next to Paris).

Latour Capital (accompagnied by BPI France, BNP Paribas Développement and Paluel Marmont Capital) supported the company's strategy, notably with respect to its relationship with Orange and public authorities, as well as through targeted acquisitions (Aubelec, Infratel, Sécurité Consultants, Sur&tis and Sysca).

Yesterday, Sogetrel's management team acquired a majority stake in the company. They are supported by a consortium of funds led by Andera Partners. This consortium notably includes Luxempart, CAPZA (via its CAPZA Mid Cap Expansion Fund), BNP Paribas Développement and IDIA Capital Investissement (via its LCL Croissance Fund).
